#### **OPPORTUNITY:**

Gold Coast Primary Health Network (GCPHN) is currently seeking expressions of interest for lived experience representatives to join the Child and Youth Mental Health Partnership Group.

#### **BACKGROUND:**

The Child and Youth Mental Health Partnership Group (CYMH-PG) has been established as part of the implementation of the Joint Regional Plan for Child and Youth Mental Health services. The Group will provide a forum for strategic input, planning, communication, and direction for stakeholders currently working in Child and Youth Mental Health Services, specialising in helping children, youth, and young adults 12-25years who have mental health needs. The Partnership Group provides the space for ongoing connection and strengthening of opportunities for cooperation between treatment providers, lived experience representatives, primary care providers and key stakeholders.

The formation of this group is in partnership with Gold Coast Health and is an important driver to continue the momentum for system improvement and collaboration across the sector that was built during the development of the Joint Regional Plan. The Joint Regional Plan was officially launched in June 2020 and can be found here: [Joint Regional Plan for Mental Health, Suicide Prevention, Alcohol and Other Drug Services](#).

#### **PURPOSE:**

The purpose of the CYMH-PG is to provide advice and leadership to support the implementation of the Child and Youth Mental Health strategies within the Joint Regional Plan, in addition to emerging priorities identified by the group. Members will use their specific knowledge and expertise to inform the best ways to facilitate implementation of prioritised strategies, with a focus on working towards achieving service integration across the region.

The Group will be expected to scope, develop, and implement activities that work towards:

- Shared understanding of referral and intake processes for clients that are accessing treatment and need to transition to another services.

- Shared understanding of communication methods regarding service capacity and demand to ensure responsiveness when transitioning clients.
- Improved connections with other providers including housing, mental health, and primary care.

#### **WHO WE ARE LOOKING FOR:**

- Lived experience (consumer or carer) of Child and Youth Mental Health services in the Gold Coast Region.
- System knowledge (private/public health supports and interventions) to provide strategic advice that supports the focus of the overarching Joint Regional Plan.
- The ability to share insights of the broader community and the interests of young People 12-25 years of age, as the lived experience voice (being connected to community consumers and/or carers).
- Ability to understand and balance the needs of different service providers, professions, and populations – the ability to take a whole of system view.
- Available to attend Committee meetings on a quarterly basis.

#### **KEY CRITERIA (must be answered – no more than 1 paragraph per dot point):**

- Please outline your Lived experience (consumer/carers/or both) relating to the Child and Youth Mental Health Service space.
- What level of knowledge around accessing child/youth mental health services in the Gold Coast region (consumer/carers/or both), will inform your contribution to the committee?
- The ability to share insights of the broader community as a representative of the lived experience voice.
- Lived experience representative training or demonstrated experience participating in committee or community group environments.

#### **COMMITMENT REQUIRED:**

- Capacity to attend quarterly meetings throughout 2022 (it is likely this group will be extended).
- Capacity to attend additional meetings (e.g. annual symposium) where required. Notice would be given well prior to these additional commitments.
- Pre-reading and evaluation/assessment of documentation related to agenda items (any that is in addition to and above the standard level of reading for a meeting – would be requested separately).
- Responsive to email and other communication related to meetings.
