# **Primary Care Video Telehealth Equipment Grant**

<u>Gold Coast Primary Health Network</u> (GCPHN) is seeking grant applications from primary health care providers who regularly service Gold Coast Residential Aged Care Facilities (RACFs) and are interested in enhancing their telehealth equipment and capabilities to enable RACF residents' greater access to primary health care. Please note, the grant funding excludes pharmacists and existing GCPHN Commissioned services.

\* To be eligible1 the applicant must be a Primary Health Care provider who provides frequent services to Gold Coast RACFs or plans too, with an average of five or more health care consultations per week.

#### Background and context to the grant funding

The Royal Commission into Aged Care Quality and Safety (Royal Commission) examined the complex issues faced by Senior Australians at the interface of the primary health care and aged care systems. These issues included a lack of access to general practitioners (GPs) and allied health professionals in RACFs, difficulties accessing after-hours care and inappropriate transfers to hospitals, which contribute to poor outcomes for Senior Australians and increased pressure on the health system.

The aim of the project is to ensure there is timely access to primary health care professionals in RACFs through enhancing access to video elehealth. This will be achieved through ensuring both primary care providers and RACFs have adequate virtual consultation facilities and technology that enables residents to access clinically appropriate telehealth care with their primary health care professionals. Please note, all Gold Coast RACFs have previously been offered the opportunity to apply for grant funding.

#### The grant opportunity

The Primary Care Telehealth Support Grants are an opportunity for Primary Care Providers to purchase the required equipment or enhance their current information technology infrastructure, which will support increasing the number of primary care video telehealth consultations offered to RACF residents.

Up to \$2,000 funding is available per primary health care provider and can be spent on overcoming any existing barriers to offering video telehealth consultation with RACF residents. This could include purchasing equipment or resources such as:

- Webcams
- Laptops/second screen
- iPad
- Headsets
- Speakers
- Internet network boosters
- Software licenses
- Information technology office set-up (both equipment and labour costs to install)

#### The initiative should not fund:

- Pharmacists
- Previously commissioned GCPHN services
- Primary Care staff or services.
- Cost of health care services.

- Primary Health Care providers who reside on the Gold Coast, but do not service Gold Coast facilities.
- Conference and/or travel related expenses
- Personal work devices that are not used to provide care.
- Devices for business-as-usual work activities not related to video telehealth for RACFs.
- Devices used for virtual social activities or work activities not related to video telehealth.

# 3 easy steps to apply

- Download the application from the GCPHN website.
- 2. Agree to the grant terms and conditions and respond to the application questions.
- 3. Once your application is submitted, GCPHN will evaluate the applications and notify suitable applicants via email within 3 weeks after the grant has closed.

# Once grant funding has been approved

- For payment, applicants must provide evidence of a valid tax invoice. Grant funds are excluding GST.
   If registered for GST, this is to be added to the invoice.
- 2. Purchase the equipment and/or technology as outlined in your original grant application.
- 3. Participate in telehealth training and education, distributed by GCPHN and partners, which needs to be completed before 30 June 2023.
- 4. Complete a Post Funding Acquittal Report provided by GCPHN, which is to be completed prior to June 30, 2023.

# Who is eligible?

To be eligible the applicant must be a primary health care provider who provides frequent services to Gold Coast RACFs or plans too, with an average of 5 or more health care consultations per week. This is based on the average number of consultations by GPs in RACFs per week (Royal Commission into Age Care Quality and Safety, 2020 pg.6-7). This is a grant for unique primary health care providers including General Practitioners and Allied Health providers. Pharmacists and current GCPHN Commissioned service providers will be excluded. Responses will be evaluated against the grant conditions and if applicants are not deemed eligible or further information is required, the project team will communicate this via email.

# How grant applications are evaluated

If eligible, the applicant's response to the below questions will be evaluated against the assessment criteria.

Applicants must respond to the following questions in less than 100 words per question

- 1. How will the funds be spent?
- 2. Estimate of costs of equipment, technology or training courses planned.

- 3. Outline how the funds will increase access to primary health care for RACF Residents via telehealth. The application should consider your commitment to quality improvement processes for telehealth, including willingness to utilise video consultations, as per best practice guidance.
- 4. How will you, as a primary health care provider, communicate your increased video telehealth capabilities to RACFs?
- 5. Outline a proposed workflow process to support the implementation of video telehealth



## **Assessment Criteria**

Applications will be assessed against the indicators listed in the criteria detailed below. Applicants will be required to address each of these criteria in their application form response. The selection criteria have been structured from <u>Australia's health performance framework</u>.

The weightings attributed to the criteria shall sum to a total of 100:
