MGT helps save time in typing, scanning and faxing paperwork. It fills service gaps and improves Medicare Benefits Scheme (MBS) compliance.

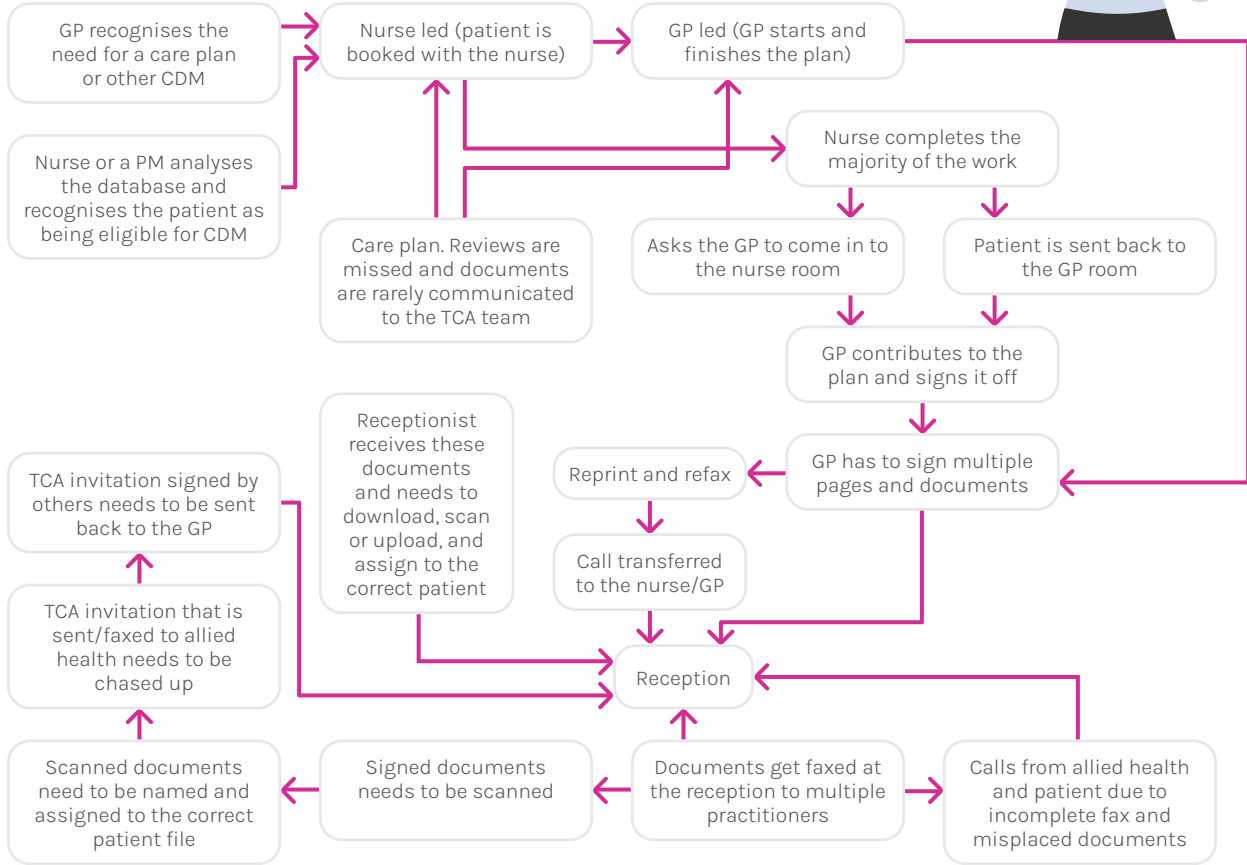
MGT is integrated with Best Practice Software and Medical Director. It adheres to the most up-to-date compliance information and approved clinical guidelines.

More importantly, MGT reduces admin burden, gives GPs peace of mind and lets practice nurses better utilise their time in clinical care.

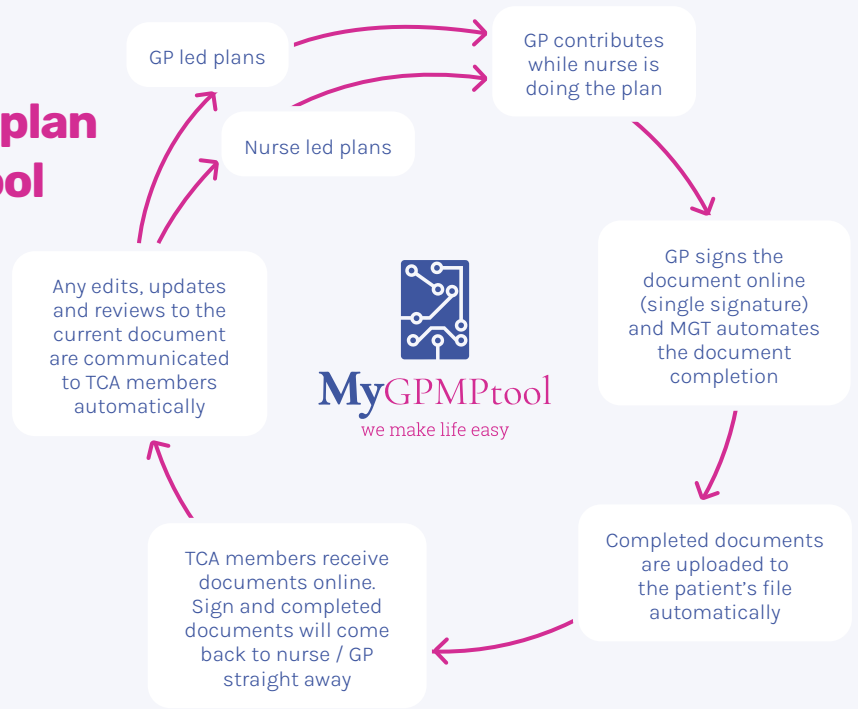

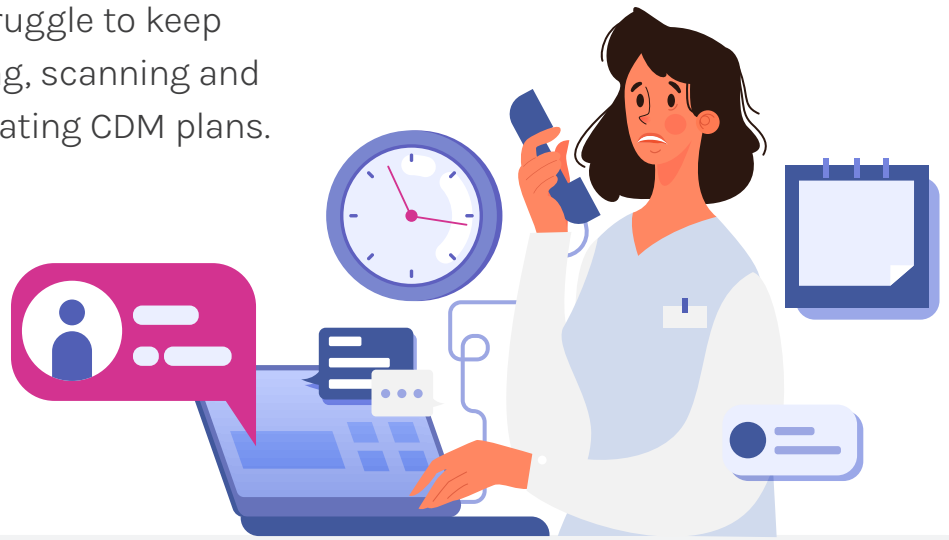


Creating a care plan with MyGPMPTool

The time consumed by some of these additional tasks cannot be billed and can cause low productivity and practitioner frustration.

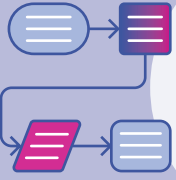

Deviation from critical compliance steps and missing vital activities



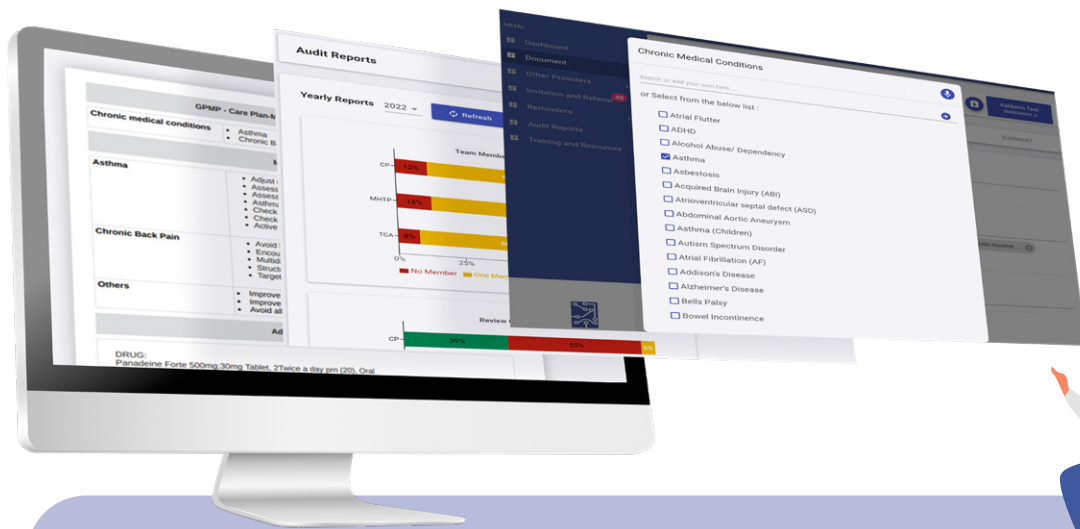
Difficulties in assessing and monitoring for compliance gaps

Template-driven care planning makes it almost impossible to self-audit for the MBS. Gaps in MBS compliance puts practitioners and practices at risk for MBS audit failures.

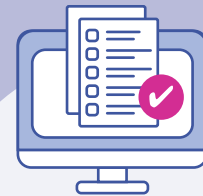

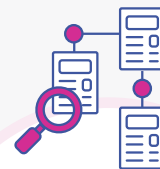

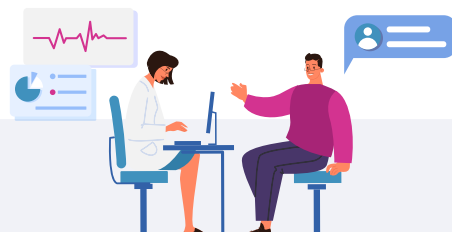
