Aim of Activity *

The purpose of this activity is to ensure that consumers are linked into service supports in the region that match their service need, including support to link with available and suitable mental health services and National Disability Insurance Service (NDIS) services in the region if/as eligible.

Description of Activity *

GCPHN will utilise the funding to commission services to deliver the following activities:

- Service Navigation: including targeted activities to assist clients with accessing stable, safe, and appropriate housing, access to food banks and referrals to other services.
- NDIS testing support: NDIS testing activities and the qualifications of commissioned service provider personnel completing testing activities are not prescribed by GCPHN; the commissioned service provider uses appropriate tools based on the presenting client's needs.
- Capacity and strengths-based assessment: commissioned service providers have indicated that the RAS- DS may not address cultural sensitivity particularly for those with English as a second language, can be time consuming and not program specific. Commissioned service providers utilise the K5, K10, GAD 7, PHQ-9 or a Goals Based Outcome tool.

GCPHN commissions service providers to deliver these activities collectively, with no specific FTE allocated to these activities within these contractual arrangements. Activities are delivered by the providers based on the capacity and capability of the workforce, and the needs of the client accessing the service. Reports are provided to GCPHN across the range of these activities.

This funding also provides for GCPHN operational costs, being GCPHN salaries of 0.75FTE (\$112,894 in 2025-26 and \$115,378 in 2026-27). No specific qualifications are required for this FTE employed by GCPHN

GCPHN will utilise this funding to:

- Establish coordinated referral processes to support consumer access to psychosocial support programs.
- Implement standardised consumer intake processes across providers.
- Work with providers to establish integrated processes for routine information sharing.
- Develop and distribute up-to-date and detailed information resources for service providers.
- Actively engage health professionals, including GPs and Aboriginal community-controlled health services.

Aim of Activity *

The purpose of the Commonwealth Psychosocial Support Program is to provide non-clinical services to assist people with severe mental illness who are not more appropriately supported through the National Disability Insurance Scheme (NDIS).

These services help people through capacity building to manage their mental illness, strengthen their relationships with families and friends, manage finances, housing, and develop living skills.

The services provide a range of non-clinical community-based support to these individuals to achieve their recovery goals, as well as support to apply for the NDIS as appropriate.

Description of Activity *

GCPHN will commission Primary and Community Care and CURA to provide psychosocial services as an integrated component of their service models.

Psychosocial activities commissioned through these providers will deliver services in scope of the guidance provided by the Department of Health and Aged Care regarding psychosocial support for people with severe mental illness.

Services will include activities such as:

- Individual and group-based supports.
- Managing mental illness working towards maintaining wellbeing.
- Social connectedness.
- Improve connections with friendships and family.
- Financial management and budgeting, support for housing.
- Physical wellbeing and health awareness.
- NDIS application supports.
- Support to link consumers with other suitable services in the region.
- Education of services supports available in the community.
- Linkage with Culturally and Linguistically Diverse (CALD) specific supports in the region.

Services will be delivered from centralised offices, and will include assertive linkages to ancillary services such as Centrelink, public housing services, psychological service providers, CALD specific service supports, community lifestyle services and other community agencies.
